

ORDINANCE NO. 1081

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ROBSTOWN, TEXAS,
AMENDING THE 2017-2018 BUDGET FOR MUNICIPAL PURPOSES; PROVIDING A
SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, on September 21, 2018, the Robstown City Council adopted Ordinance No. 1074 authorizing an operating budget for Fiscal Year 2018; and

WHEREAS, since the adoption of the Fiscal Year 2018 budget, there has arisen a need to amend the Fiscal Year 2018 Operating Budget for the adjustment to various budget accounts to properly account for unrealized revenue as illustrated in **Exhibit A**; and

WHEREAS, the City Council finds it in the public interest to amend the total Fiscal Year 2018 Operating Budget by adjusting various budget accounts as outlined in **Exhibit C**.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROBSTOWN, TEXAS:

SECTION 1. The findings and recitations set out in the preamble to this Ordinance are found to be true and correct, and they are hereby adopted by the City Council and made a part hereof for all purposes.

SECTION 2. The City Council hereby authorizes an amendment in the amount of seven hundred fourteen thousand twenty-five dollars (\$714,025) to the total Estimated Revenues Budget and nine hundred nineteen thousand nine hundred fourteen dollars (\$919,914) to the total Appropriations Budget for Fiscal Year 2018 as outlined in **Exhibit B**; incorporated herein for all intents and purposes.

SECTION 3. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this Ordinance should be declared invalid by the final judgment or decree of any court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections of this Ordinance.

SECTION 4. All Ordinances or parts thereof in conflict herewith are repealed to the extent of such conflict only.

SECTION 5. This Ordinance shall be and become effective from and after its adoption and publication in accordance with the provisions of the Charter of the City of Robstown.
