

ORDINANCE NO. 1095

**AN ORDINANCE OF THE CITY OF ROBSTOWN, TEXAS
AMENDING ROBSTOWN CODE OF ORDINANCES
CHAPTER 6 HEALTH & SANITATION, ARTICLE 6.07
SOLID WASTE, DIVISION 4. RATES AND CHARGES;
BILLING, SECTION 6.07.091 MONTHLY CHARGE.**

WHEREAS, the City Council has deemed it appropriate to modify the solid waste rates and charges assessed by the City of Robstown (“City”) and find said rate increases to be in the best interest of the City; and

WHEREAS, the City Council has determined that the increases are reasonable base on the services provided and in consideration of the current rates utilized by similarly situated municipalities;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROBSTOWN, TEXAS:

SECTION 1. Chapter 6, Article 6.07, Division 4, Section 6.07.091(2) and (3-A) is hereby amended to read as follows:

Sec. 6.07.091 Monthly charge

.....

(2) For each single-family residential, duplex, and multifamily residential (includes apartments of 3–4 units) the charge shall be \$28.34 per month for collections, to be paid by the occupant or person arranging utility service for such residence or living unit. Occupants desiring more than one roll-out container shall be charged an additional \$10.00 per month for each additional container.

(3) The fees set

(A) Customers shall be charged a fee of \$41.17 per month for each roll-out container for collections. Occupants desiring more than one roll-out container shall be charged an additional \$10.00 per month for each additional container.
