

**ORDINANCE NO. 1092**

**AN ORDINANCE OF THE CITY OF ROBSTOWN, TEXAS  
AMENDING ROBSTOWN CODE OF ORDINANCES  
CHAPTER 6 HEALTH & SANITATION, ARTICLE 6.02  
EMERGENCY MEDICAL SERVICE DEPARTMENT,  
SECTION 6.02.001 RATES AND CHARGES.**

**WHEREAS**, the City Council has deemed it appropriate to modify the emergency medical service fees assessed by the City of Robstown ("City") and find said fees to be in the best interest of the City: and

**WHEREAS**, the City Council has determined that the increases are base on the services provided and in consideration of the current fees utilized by similarly situated municipalities;

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROBSTOWN, TEXAS:**

**SECTION 1.** Chapter 6, Article 6.02, Section 6.02.001 is hereby amended to read as follows:

Sec. 6.02.001 Rates and charges

(a) The city shall be empowered to make upward or downward adjustments in rates to be able to provide the best quality care, including advanced life support (ALS).

(b) Charges for emergency medical service shall be as follows:

Base rate:

BLS (Basic Life Support)	\$650.00
ALS1 (Advanced Life Support 1)	\$800.00
ALS2 (Advanced Life Support 2)	\$900.00
MILEAGE	\$15.00
OXYGEN/SUPPLIES	\$15.00
No Treat/No Transport	\$75.00
Treat/No Transport	\$150.00

Cardiac supplies, IV supplies, Respiratory equipment, Splints, Meds. and Miscellaneous equipment/supplies rates will be deleted.

**SECTION 2.** This Ordinance shall take effect on October 1, 2020.






